### **Notice Inviting e-Tender**

[Notice Inviting e-Tender Vide No.- HIDCO/GM(E)-I/NIT-01/2024-25 of The General Manager (Engg.)–I, WBHIDCO Ltd].

An e-tender is hereby invited by the General Manager (Engg.)-I on behalf of WBHIDCO Ltd., from the bonafide, resourceful and experienced Security Agencies having experience in similar nature of job for the work of "Engagement of Security Guards without Fire Arms and Guards with Fire Arms as per the proper roster of duty for 24 hours in different Establishment under General Manager (Engg.) - I, WB HIDCO, New Town, Kolkata".

#### A) Scope of work:-

- 1. Engaging of security guard and security supervisor as per duty allocated by the concerned officer in three shifts in various locations of WB HIDCO Ltd.
- 2. After office hours all lights, fans & A.C. should be put off and properly locked of office chambers and premises.
- 3. During duty hours security guards should be properly dressed.
- 4. Duty hours will be in three shifts. If there be any change of security personnel should be informed to the concerned officer, WB HIDCO beforehand.
- 5. The Agency should financially sound so that thet can made payment to the Seurity gurds for 3 months before getting bills from HIDCO.
- 6. Salary to be paid within 6th day of the next month.

#### **Completion Period:-**

1 (One) year from the date of commencement

#### **Earnest Money:-**

**Rs. 50,000/- (Rupees Fifty Thousand) only in favour of WBHIDCO Ltd.** to be deposited online through e-tender portal payment gateway. The process of deposit of earnest money by the bidder will be deposited by electronically online. Intending bidder will get the beneficiary details from e- tender portal with the help of digital certificate.

Total Performance Guarantee will be Rs.1.00 (one) lakh out of which Rs. 50,000/- (fifty) thousand will be in the form of EMD and the balance part to be submitted at the time of making agreement by the successful bidder. Balance Earnest Money may be remitted through Demand Draft / Pay Order issued from any Nationalized Bank in favour of the "WBHIDCO Ltd." payable at KOLKATA.

After completion of contract the Security Deposite money will be relaeased.

#### B) General Terms & Conditions of Bid: -

- 1. The contract shall commence from the date of execution of the Contract Agreement by WB HIDCO Ltd. with the Security Services providing Company / Agency and shall continue for a period of one year, unless it is terminated by this Corporation due to deficiency in Service Sub Standard quality of deployed manpower, delay in payment to Security guards by the Agecny/breach of terms and condition of the Contract. It is also noted that the said work may be extended up to 3 years in phases with prior consent of both parties if performance of the Agency is satisfactory to the Notice Inviting Authority.
- 2. The agency will be selected in two steps. If the agency full fills the technical criteria then he will be qualified in the Price bid Competition.
- 3. a) The agency should only quote their service charges in % (Percentage) only. The Service charge will be paid on the gross salary of security personnel including other taxes, if any.
- b) The Service charge in percentage will be above 0 (zero) percent but not more than 10 (ten) percent. If the qutoted percentage is zero or less that shall not be accepted. Moreover, quoted rate above 10 percent shall not be accepted.
- 4. Agency will pay wages to the Security Personnel as per the latest rates of minimum wages delaired by the Govt. of West Bengal Labour Department. If the Govt. give increment in the wages, the concernd agency have to give the same effect of increment on the wages to the Security guards.
- 5. The agency will pay monthly wages along with PF, bonus and ESI as per Rules as per respective Act.
- 6. The agency will provide two sets of dresses including Shoe in an interval of 1 (Year), Wind Cheater (1 No.), Sweater (1 No.) in Winter, Umbrella (1 No.) in Rainy Season & Rain Coat (1 No.), Torch (1 No.), Photo Identity Card-1 No., etc. The cost of these articles shall be bourne by the Agency from their Service Charges. All these articles shall have to be provided within a month to the security parsonned from the date of issue of work order.

If the Security Agency would fail to these articles to the security guards within 1 (one) month from the date of issue of work order, recovery shall be made from the bill of the Security Agency from the 2<sup>nd</sup> RA bill as follows:

Shirt : Rs. 750.00 each b) Trousers/ Full Pant : Rs. 800.00 each : Rs. 2500.00 each Shoe c) Wind Cheater : Rs. 500.00 each d) : Rs. 500.00 each Sweter Umbrella : Rs. 300.00 each f) Rain Coat : Rs. 500.00 each g) Torch : Rs. 125.00 each : Rs. 50.00 each Photo Identy Card

- 7. The intending bidders have to deposit a sum of **Rs. 50,000/- (Rupees Fifty Thousand)** only as earnest money through e-tender payment gateway payable at Kolkata only of the successful bidder after issue of work order. No separate payment shall be paid from WB HIDCO. It will be converted into Security deposit.
- 8. The agency will pay the monthly salary of security personnel within 6th day of every month. They will deposit the salary bill along with bank statement of all satisfactory payment of all the security personnel also with service charge on gross value of wages to WB HIDCO Ltd. WB HIDCO Ltd. will reimburse along with service charge within a month if the bill is found in order.
- After proper submission of the document for payment towards the security personnel along with PF, ESI, P. Tax, Paid Chalan and Bonus. WB HIDCO Ltd. will reimburse the total amount along with the Service Charge Quoted by the agency.
- 10. There shall be no provision of Arbitration.

#### C) Eligibilities Criteria: -

- 1. Intending agency should have minimum annual turnover of Rs.50 (fifty) Lakh during last 03 (three) financial years.
- 2. Intending agency has not been blacklisted by any Govt./Govt. undertaking company during last 03 (three) year from the date of notice for this tender.
- 3. Intending Security agency having valid license for Security Services from Home Department i.e., Psara.
- 4. Intending agency must have an office in Kolkata.

- 5. Intending agency have experience of Providing security guard in different capacities throughout the year to any Govt. Department for a minimum period of 03 (three) years.
- 6. <u>Perfomance Secutiy:-</u>Total performance security deposit will be Rs.1.00 (one) lakh out of which Rs.50,000/- (fifty) thousand will be in the form of EMD and the balance part to be submitted at the time of making agreement by the successful bidder through Demand Draft / Pay Order issued from any Nationalized Bank in favour of the "WBHIDCO Ltd." payable at KOLKATA.

After completion of contract the Security Deposite money will be relaeased.

7. The work may be distributed equally among lowest bidders in the event the lowest bid quoted by two or more bidders as per discretion of Tender Inviting Authority. If the work shall be distribted among two or more bidders, the performance Security amounting to Rs. 1,00,000.00 (Rupees One Lakh) only to be deposited by all the agencies sepeartely.
